Stage-1. Expression Of Interest (EOI)

The J&K State Sports shall short list only those Vendors who fulfill the criteria as given below.

- 1. The applicant/vendor/ firm be I.T professional company/firm under respective act.
- 2. The applicant/vendor/ firm shall have experience of executive similar projects.
- 3. The applicant/vendor/ firm should have Technical qualification and well experiences resources.

- 4. The applicant/vendor/ firm should furnish undertaking that the firm has not been black listed in India.
- 5. The applicant/vendor/ firm has to fill form 1 & 2.

Stage-2. Request for Proposal (RFP)
