NOTIFICATION

1. Whereas 14 applications were received by the J&K Sports Council in response to the Notification dated: 07-04-2022 floated for grant of sports category weightage to the applicants desirous to appear in Common Entrance Test for admission to B.Sc. Nursing/B.Sc. Para Medical/B.Sc. Technology -2022 courses under sports category and or;
2. Whereas the applications were scrutinized by the committee constituted for the purpose on 18-05-2022 at New Administrative Block Bakhshi Stadium Srinagar in terms of criteria laid down under Govt. No: 808-GAD of 2008 dt:-17-06-2008, 946-GAD of 2008 dt:15-07-2008, 1090-GAD of 2008 dt:14-08-2008 & 733-GAD of 2010 dated: 24-06-2010 and or;
3. Whereas thirteen candidates appearing at S.No.: 1, 2, 3, 4, 6, 7, 8, 9, 10, 11, 12, 13 & 14 of the list as per Annexure-'A' have been found eligible and awarded sports points for their sports representations at National level etc and or;
4. Whereas one candidate figuring at S.No.: 5 of the list as per Annexure-'A' have also been found eligible and awarded sports points for their sports representations at National level etc. subject to authentication/verification of their sports certificates by respective recognized Sports Federations within a period of one week from the date of communications issued by the J&K Sports Council to the concerned quarters and or;
5. Whereas, the committee recommended conduct of physical test and viva of the eligible candidate at Srinagar & Jammu to ascertain the proficiency of the game/sport opted.

In view of the above, objections/grievances, if any, with regard to eligibility of candidate, or otherwise including point allotted/observations to their sports achievements made by the committee are therefore invited which should reach to this office at New Administrative Block, Bakhshi Stadium, Srinagar on or before on 27-05-2022 during office hours in hard and soft copy. Soft copy can be emailed to jkstatesportscouncil@gmail.com. Objections/grievances after prescribed date shall not be entertained. The decision of the committee shall be final in such matters.

The eligible candidate shall report to Sports Officer(K), J&K Sports Council Pologround playing field Srinagar & Sports Officer(J) J&K Sports Council at New Indoor Sports Complex M.A. Stadium Jammu alongwith track record and proper identification proof on 23-05-2022 during office hours for physical verification test/viva. In case the candidate fails to appear for physical verification test/viva on the scheduled date, her/his sports category weightage shall not be recommended to BOPEE or other Professional Institutions. No individual intimation to the candidate shall be dispatched to this effect.
