Sub: - Conduct of final selection Trials for Inter Divisional Athletes at Jammu for raising the UT contingent for 76<sup>th</sup> National Football Championship for Santosh Trophy 2022-23.

1. Whereas Committee(s) at Divisional level were Constituted to conduct selection trials for raising the UT contingent for participation in 76<sup>th</sup> National Football Championship for Santosh Trophy 2022-23, and;
2. Whereas, selection trials at Divisional level were fixed on 2<sup>nd</sup> and 3<sup>rd</sup> December, 2022 at Srinagar as well as a Jammu and respective committees were given mandate to select the athletes at Divisional Level, and;
3. Whereas, J&K Football Association has not taken on board the officers/experts/coaches for conduct of selection trials at Divisional trials and thus failed to submit the list of selected players duly authenticated by the all members of the committee(s), and;
4. Whereas, the final selection trials fixed on 5<sup>th</sup> December, 2022 at Mini Stadium, Parade were required to be conducted by the committee constituted for the purpose under the supervision of the Joint Secretary (K), J&K Sports Council, and;
5. Whereas, the Joint Secretary (K), J&K Sports Council reported that no list either from Jammu or from Kashmir has been signed/authenticated by the respective Divisional Sports Officers, Jammu/Kashmir neither any coach nominated for the conduct of trials has signed the selected list as per the orders already issued as such the selection cannot be taken up for such players who stood selected exclusively by J&K Football Association at the division level, and;
6. Whereas, the matter was examined and it was of considered view that final selection trials shall be cross checked/finalized for inter divisional athletes by the following experts under the supervision of Secretary, J&K Sports Council: -
  - a. Sh. Wasim Aslam, Chairman Election Committee, JKFA
  - b. Sh. Satpal Singh, Manager (Football expert).
  - c. Sh. Javaid Ahmad Sofi, Football Coach.
  - d. One representative from JKFA.

In view of the above, the selection of the team to be represented for UT of J&K in Santosh Trophy shall be cross checked/finalized by the above committee on 7<sup>th</sup> of December, 2022 at 02.00 P.M. at Mini Stadium, Parade, Jammu under the supervision of Secretary, J&K Sports Council.
