Subject: New Election schedule for the Election of J&K KHO-KHO ASSOCIATION 2024-28 for a period of 4 years.

Sir,

In continuation of my Election Schedule issued on 11.02.2024 pertaining to elections of Jammu & Kashmir Kho-Kho Association it is hereby, informed that the date of Filing Nomination Papers is extended. The last date for filing Nomination Papers as per the change in the Election Schedule is now extended upto 20.02.24, without changing the date of Elections which is already notified as 24.02.24.

It is further clarified that the date for filing Nomination papers has been extended due to some confusion within the candidates regarding the specific guideline issued by the J&K Sports Council that **"No Office bearers of an Association shall be eligible to be office bearers simultaneously in other association except Olympic Association"**. The candidates needed some time to clarify it from the J&K Sports Council also as such, to give maximum opportunity to all eligible candidates to participate in the election process the date for filing Nomination Forms is extended from 17.02.24 to 20.02.24. In view of extension of date in filing Nomination papers, the date for scrutiny of Nomination papers as such, is changed from 18.02.24 to 20.02.24 and the withdrawal of Nomination Papers is changed from 19.02.24 to 21.02.24.



- iv. Date of Election, if any 24.02.2024
