It is obligatory upon the Sports Associations recognized by J&K Sports Council to conduct domestic and national level activities including selection trials/ pre participation coaching camps and hosting of Nationals on allotment basis for the year 2024-25 in a planned manner to achieve the desired results and focus on youth engagement. All recognized sports associations are accordingly directed to furnish the calendar of activities proposed at various level during the financial year 2024-25 in the following format on or before 15<sup>th</sup> April, 2024 in both hard and soft copies:-

2. Utilization certificate of grants received during 2023-24 alongwith refund of unspent grant if any including settlement of outstanding audited accounts.

4. Details of medals earned by Sports persons in National and other level of competitions during 2023-24.
5. Detail of sports persons who represented in International competition during 2023-24.

It is pertinent to mention that sports associations which fail to render the calendar of activities within the stipulated period shall not be eligible for the grant in aid under any circumstances. Such association which are defaulter in respect of settlement of outstanding audited accounts, breach of constitutional provisions, violation of sports council guidelines or facing management dispute / non-conduct of elections on due dates shall not be eligible for any kind of assistance from J&K Sports Council. In such cases, the activities shall be conducted by the Sports Council itself for the welfare of the sports persons engaged in such sports disciplines. They are also advised to conduct selection trails / UT championships including pre participation coaching camps at Jammu Division during winter season and at Kashmir Division during Summer season subject to availability of facilities.
