The disciplines (Sports/Games) covered under the above rules are athletics, Badminton, Basketball, Cricket, Football, Hockey, Swimming, Table Tennis, Volleyball Tennis Weight Lifting, Wrestling (International Style) Boxing Cycling Gymnastics, Judo Shooting Archery Equestrian, Handball Rowing Roller/Ice Skating, Skiing Squash, Billiard & Snooker, Chess Golf Kabaddi, Karate, Kayaking Canoeing, Polo, Power Lifting, Taekwondo, Yachting, Kho-Kho Body building Ball Badminton Bridge, Tennikoit, Carrom Softball, Wushu, Sport Climbing, Thang-Ta Baseball and all other games falling within the purview of Indian Olympic Association and or recognized by the Government of India.

terms following follow also should The candidate conditions/guidelines in addition to qualifying criteria while filling up the application form for grant of sports category weightage.

1) Provided that for purpose of determination of the merit under sports at Courses **Professional** selection to for Graduate/Graduate/Diploma level etc. 60% weightage shall be given to the merit obtained by the candidate in the Entrance test conducted by the Selection agency & 40% weightage shall be given to the level of sports participation. The 40% merit shall be distributed as per the following criteria:-

2) The candidates who fulfill the above qualification in addition to minimum required Academic qualification should be of the age as may be prescribed by the Board of Professional Entrance Examinations, J&K. The applications duly completed enclosing their with the following certificates in original as well as a set of Photostat copies duly attested

by the competent authority should deposited with respective Sports Officers of the Sports Council within the stipulated date: -

- State subject certificate / Domicile Certificate.
- Sports achievement certificates duly affixed with a photograph II. and verified by the respective Sports Associations/Directorate III. of Youth Services & Sports/other competent bodies.
- Certificate of qualifying examination. IV.
 - An affidavit affirming the authenticity of the claim(s) duly attested by the Magistrate (1st Class) on non-judicial stamp ٧. paper on prescribed format available in the office of Sports Officers, Sports Council Srinagar/Jammu with the application format.
- The applications should be deposited with the following officers of the Sports Council within the prescribed period as per the Council 1. advertisements. The applications received before or after the prescribed dates or through other agencies shall not be entertained:
 - a) Divisional Sports Officer, J&K Sports Council, Bakshi Stadium Srinagar.
 - b) Divisional Sports Officer J&K Sports Council, New Indoor Sports Complex, M.A. Stadium Jammu.
 - Incomplete application form will not be considered. 2.
 - The certificate of participation in International events will be 3. considered and recognized by the Sports Council if these are issued by following and genuinely signed by its office bearers including the Organizing Secretary or/and Secretary General:
 - a) Respective Host Country, or.
 - b) Respective International Federation, or.
 - c) Respective recognized National Federation.
 - 4. The certificates issued by the recognized National Federation will only be accepted.
 - 5. The certificate of participation National level competitions will be considered or recognized by the Council only if these issued by the respective National Federation or its affiliated State Units authorized to conduct the particular event. The certificate should be genuinely signed by the competent office bearers of the respective National Federation including the Secretary General or/and Organising Secretary of the event. In case of Cricket or some other discipline, the certificates issued by the recognized State Sports Association will be considered against an affidavit to the effect that the Organisors or Board of Control for Cricket in India/some other National Federations has not issued the participation certificates.
 - 6. After the applications are scrutinized by the Committee, the Sports Council will notify the list of eligible and ineligible candidates and will call

- objections/grievances from the candidates with regard to any applicant, whose name is notified, regarding his/her claim under Sports Category. The committee will consider the objections/grievances of any applicant. The decision of the Committee shall be final in such matters.
- 7. The candidate should deposit the sports certificates in original alongwith the application which shall be retained by the Council for 15 days from the date of publication of list of eligible & ineligible candidates. A set of photo copies duly attested/verified should be submitted by the candidate. The candidate should also give complete address and telephone number, if any for correspondence/contact.
- 8. The sports achievement certificates produced by the candidates will be subject to cross checking whenever found necessary.
- 9. Candidates found guilty of impersonation or submitting fabricated/tampered documents or making statements which are incorrect/false or suppressing material information may, in addition tendering him/her liable for criminal prosecution, be debarred, or for a specific period, from being considered for any or all admission made under these rules.
- 10. The applications shall be considered on the basis of records/documents produced by the candidates and verified by the respective State sports Associations/other competent bodies.
- 11. As per the decisions taken in the 53rd meeting of the Sports Council held on 19-02-2013 under the Chairmanship of Hon'ble Chief Minister (President, Sports Council), the sports certificates of the applicants earned from April, 2013 onwards at National level shall only be entertained for the purpose of sports category benefits if the respective State teams/contingents deputed by the J&K State Sports Associations are duly screened/recommended by the Screening Committee of the J&K State Sports Council.
